## APPOINTMENT OF ADDITIONAL DIRECTOR

Prior to joining Temasek, Mr Eng was co-founder of TE Asia Healthcare Partners, a company largely funded by TPG Capital to spearhead specialty healthcare investments in Asia, and Group CEO of TE Healthcare Advisory Pte Ltd. Mr Eng successfully grew the business and exited it in 2024. Before joining the healthcare industry, Mr Eng spent 18 years with Neptune Orient Lines in various leadership roles. Mr Eng graduated with a Bachelor of Accountancy degree from Nanyang Technological University and an MBA from Harvard University.

Mr Nagi Hamiyeh, a Non-Executive and Non-Independent Director, will step down from the Board at the coming Annual General Meeting of the Company on 23 April 2025.

Welcoming Mr Eng to the board, Mr Mark Gainsborough, Chairman of Seatrium's Board of Directors, said: "We are delighted to have Aik Meng join us on the board. With his extensive experience in the maritime, private equity and healthcare industries, Aik Meng will value add to the Board, enhancing and complementing the Board's existing competencies and skillset.
