(A) Temasek's deemed interest through Startree	35.794%
(i) Startree holds 35.794% of Shares.	
(ii) Startree is a subsidiary of Fullerton Management Pte Ltd ("FMPL").	
(iii) FMPL is a subsidiary of Temasek.	
(B) Temasek's deemed interest through Fullerton	0.166%
(i) Fullerton has an interest in 0.166% of Shares as investment manager for various funds, including funds in which Temasek through a subsidiary has an interest.	
(ii) Fullerton is an indirect subsidiary of Temasek.	
(C) Temasek's deemed interest through DBSH	0.034%
(i) DBS Bank Ltd. ("DBS Bank") holds 0.034% of Shares.	
(ii) DBS Bank is a subsidiary of DBSH.	
(iii) Temasek has an interest of more than 20% in DBSH.
